Seismic Upgrades for Surrey Schools

The Minister of Education made a \$10 million dollar announcement for Surrey schools on Friday, December 15. Rob Fleming stated that the announcement was "long overdue" for Mary Jane Shannon and Bear Creek elementary schools, both of which are considered "high-risk". Construction to complete the seismic upgrades to these facilities is scheduled to begin in the fall of 2018. This good news comes just one week after the Province announced the creation of 955 new classroom seats for Surrey students last Friday. You can follow this story ONLINE.

Bargaining Bulletin

Congratulations to Violette Baillargeon and Kevin Amboe who were elected as co-Chairs of the STA Bargaining Committee at last week's meeting. It's time to start thinking about the next round of contract negotiations, happening in 2019. Keep an eye out for a survey-questionnaire about bargaining objectives, coming to members in the spring. In the meantime, continue holding regular union meetings to discuss specific school concerns.

Remedy for Class Size and Composition Violations

Classroom teachers whose classes exceed the class size and/or composition limits in the restored language are owed remedy for each month, beginning with October. The District has developed a software tool to record and calculate the remedy owed to each teacher for each month. There has been some delay in rolling out the system but the District expects teachers to be receiving notification of the remedy they are owed, expressed in minutes, for each month. The forms of remedy that are available are a) prep time; b) non-enrolling teacher time to work with the teacher's class; and c) teacher time to co-teach in the teacher's class.

A Clean Sweep at PBC!

Thank you to all the teachers who responded to the Calls to Action in the Monday Memo and through social media by showing up and participating in the Pacific Blue Cross Annual General Meeting last week.

STA President Gioia Breda attended the meeting, and said, "The energy in the room was palpable! It was clear people wanted a change." She, alongside other Table Officers Julia MacRae and June James, were thrilled to see so many Surrey teachers participate. They remarked that there were BCTF Members present from across the Lower Mainland and the Fraser Valley, and that it was nice to see such a wonderful display of solidarity!

Breda noted that it is important for teachers to show up to support other workers in their times of need, because CUPE and other unions supported us when we're on job action. The PBC workers that were locked out are members of CUPE, and CUPE did an incredible job of running a public campaign to advocate for change, and organizing opportunities for member participation (including arranging transportation from various locations throughout the Lower Mainland).

It was a packed house at the AGM, and the progressive candidates that ran for seats on the PBC Board of Directors won by a landslide! Julia MacRae commented, "Seeing everyone come together really speaks to the power of the people, and the power that we have as union members." The STA was pleased to see former BCTF President Jim Iker be elected, along with BCFED Secretary-Treasurer, Aaron Eckman. Read the news release from CUPE BC HERE.

It's that time of year! If you haven't submitted your medical/extended-health benefit receipts for reimbursement, now's the time to do it! In some cases, you might have a 24-month window, but take the time now to check to make sure you're not leaving money on the table! With PBC employees being locked out earlier this year, there has been a delay in processing reimbursements. If you're still waiting on a claim, it would be worthwhile to follow up and make sure it was received.

Call for Delegates!

Each year over 750 delegates from around the province attend the BCTF AGM, held during Spring Break. It is a great opportunity to see how the BCTF operates, to hear new perspectives on important issues, meet colleagues from other parts of the province, and to have a voice in the decisions made by the union. Hotel accommodations and expenses are covered by the BCTF. Childcare arrangements are also available.

Surrey is able to send up to 60 delegates. Under the STA's Policies and Procedures, the 10 members of the Resolutions Committee automatically become delegates, therefore we need to elect 50 delegates plus alternates.

Delegates will be elected at the Special General Meeting on January 24 at the Bombay Banquet Hall.

IST Caseload Ratio

With the restored Collective Agreement language, the IST - student ratios have been restored to 1:15.

If your IST ratio is greater than 1 teacher per 15 students, please contact JOANNA CERAZY.

Privacy, Please!



The STA is concerned that there may be professionals, like school counsellors, who have been asked to share office space with other non-enrolling members on their work days when their roles require them to have a private space because of the confidential nature of their work. These roles may also require these members to have locked filing cabinets to ensure student information is kept private. This does not include sharing an office space on alternating work days. If you feel that the integrity of your work is being compromised because the District has not provided adequate space for the work you do, or has not provided you with a locked filing cabinet if the nature of your work requires it, please contact JOANNA CERAZY as soon as possible.

Is Special Education Understaffed?

The Special Education class size and composition limits apply to the BASES programs and programs for students with Severe Behaviour Designations. So far, the District has applied a 10.5 student per 1 full time teacher average to assign staffing. However, in some cases, this might mean that programs have been understaffed. Please check your ratios to ensure that you have received appropriate staffing for your classes. Contact JOANNA CERAZY with questions or concerns.

The class size and composition language is as follows:

1 FTE per 12 students: students with MID designations and MID/MOD combination

1 FTE per 8 students: M0D designations

1 FTE per 7 students: Multicategory - M0D, MID, ASD, Severe Profound designations or a combination

1 FTE per 6 students: Multicategory - ASD, Severe Profound, Physically Dependent

Social Development Programs in Elementary

With the restoration of the Collective Language, class size limits for Social Development Programs are back. The teacher - student ratio for these programs is one FTE per 8 students. It is our understanding that these numbers are being followed, but if you believe that your Social Development Program does not have appropriate staffing, please contact JOANNA CERAZY.

Teachers are noticing the increasing numbers of students in their classes who are exhibiting behaviours that are problematic and perplexing. Teachers aren't expected to be psychologists or medical practitioners in resolving these issues, but there are ways for them to help students with mental health issues.



"The End of Poverty? Think again."

A film by Phillipe Diaz, narrated by Martin Sheen. (104 minutes)



"The End of Poverty?" is a daring, thought-provoking and very timely documentary by award winning filmmaker Phillipe Diaz, revealing that poverty is not an accident. It began with military conquest, slavery, and colonization that resulted in the seizure of land and other natural resources as well as in forced labour. Today, global poverty has reached new levels because of unfair debt, trade and tax policies- in other words, wealthy countries exploiting the weaknesses of poor developing countries. "The End of Poverty?" asks why today 20% of the planet's population uses 80% of its resources, and consumes 30% more than the planet can regenerate. Can we really end poverty under our current economic system? Think again. (- source - back of DVD case).


