# Notice of Annual General Meeting

#### Call for Nominations

We will be holding elections for Executive Committee positions, including table officer positions as well as the Resolutions Committee. We will also be adopting the STA budget for 2018-19, and setting the STA fee. ### Important Information about Remedy

The District is in the process of organizing staffing at schools to begin providing remedy to teachers who are owed it this year. We will be sending further details in the near future, but want to highlight a few important points:

#### 1. Remedy does not disappear at the end of the school year.

The Memorandum of Agreement (MOA) between the BCTF and BCPSEA does not expressly state what happens to remedy that has not been delivered by the end of the school year, except that the parties will discuss it. Our understanding from the BCTF is that the BCTF and BCPSEA agree that remedy that is not used does not disappear at the end of the school year. They disagree on how it will be handled. The BCTF's position is that remedy carries over to the next year in the form it was selected (i.e. prep time, non-enrolling time, or co-teaching time). Our understanding is that BCPSEA disagrees that it carries over in these forms, and believes that it would need to be monetized in some form (which would have to be agreed to by the local union and employer). The provincial parties are in discussions on this issue.

2. Teachers are not required to take remedy at a time when it will not be helpful to them. With all the remedy that is owed, and the limitations of staffing, people may not be able to get their first choice in terms of the scheduling of remedy. If you have an opportunity to get some or all of your remedy, and it will be helpful to you (as opposed to creating more work for you), then by all means do so.

#### 3. Teachers are not required to prep for their remedy.

You are not required to create a plan for a remedy period. This may be a more realistic proposition for some teachers than for others, depending on what they teach and what they had planned to do at those times.

4. Teachers are not required to stick with their original choice for remedy delivery if it no longer makes sense.

Teachers whose classes generated remedy this year were asked to choose whether they would prefer remedy to be delivered in 1 of the 3 following ways: a) prep time; b) non-enrolling teacher time to work with the teacher's class; and c) teacher time to co-teach in the teacher's class. If that choice no longer makes sense, you are not required to stick with your original choice. You and your colleague delivering your remedy are both professionals. You can use your professional judgement at this time to choose which of the 3 delivery methods currently makes the most sense and discuss that with your colleague. For example if in term 1 you had no prep and you chose prep as remedy, but this term you have a prep block, you may feel another teacher working with your students 1-1 is more beneficial.

Please stay tuned for more information about remedy as it becomes available.

It does this in a way that provides teachers and educators with vocabulary, information, and pedagogical strategies so that they, in turn, can bring these important conversations into their schools and classrooms." "Keith Thor Carlson is a professor of History and Research Chair in Aboriginal and Community-engaged History. Born and raised in Powell River on BC's west coast, his scholarship focuses on the Salish people of British Columbia and Washington State. He was adopted as an honorary member of the Sto:lo Nation in a potlatch ceremony in 2001. He also has emerging research relationships with Cree and Metis communities in Canada's prairie region. Another research interest remains in mid-twentieth century Philippine peasant history, and in particular in the history of the Hukbalahap. He is actively engaged in graduate supervision and considers community-engagement fundamental to both his and his students' research. Outside academia, he continues to receive ongoing education from Salish knowledge keepers and knowledge interpreters."

#### Failures-to-Fill

Colleagues, as you are well aware, there is no end in sight to the ongoing TTOC shortage. Every single day there are hundreds of students in school without a teacher. On April 12, 2018, a job-posting bulletin went out that was 53 pages long! While we hope that the District is able to find teachers for those classrooms, we realize that the TTOC will be further depleted. As frustrating as it is to lose your prep, please remember that it is not your colleague's fault if there was nobody else available to take their class while they were away.

Two important things to remember: Be kind to one another and TRACK! TRACK! TRACK!

This year we are particularly concerned in having ALL THE FAILURES-TO-FILL tracked, not only because of the TTOC shortage, but also as a way to verify if the District is actually failing to meet its district-wide ratios for LST, by having service to those students routinely pulled to cover for other teachers, particularly in elementary school.

School Staff Committees have had success drafting procedures outlining protocols for how failure-to-fills will be covered within their schools. For example, Failures-to-Fill would be covered first by administrators, followed by teachers on prep, and lastly by pulling LST (and/or other non-enrolling) teachers. While it is certainly frustrating to lose your prep-time, at least there are systems in place for recovering that time, eventually. It is important to keep track, for your own records, when you are asked to cover someone else's class during your prep.

At the school level, STA Reps should be keeping a detailed record of who is being pulled to cover in these ongoing situations of failures-to-fill. Access the tracking form **ONLINE** and please forward a copy to Grievance Officer, **MARK KEELAN**. This data will help us understand if ratios are being met, and will help us advocate to the District with respect to the impact of failures-to-fill.

# Are your students at risk of death or injury?

On average, 27 young workers are injured on the job each day in British Columbia. With many secondary students working part-time, one of them could be in your classroom.

BC workers under the age of 25 face particular occupational risks and hazards, often as a result of inadequate training, education, supervision, understanding or instruction regarding the dangers of their workplace, and the rights and regulations surrounding safe workplaces.

Young worker awareness education can start in our schools.

Annually, over 120 BC schools take part in the Day of Mourning B.C. using scripts, posters, postcards, and a powerful video featuring Matthew Bowcott telling the story of his workplace injury. Daily scripted announcements lead up to the day of observance, which saw the students respectfully holding a moment of silence after a formal address.

**April 28, 2018** marks the National Day of Mourning, to remember the hundreds of workers killed on the job each year, and to advocate for safer workplaces for all.
