### Covid concerns and teacher stress

We know the number of exposure notifications in our schools is alarming to many members. Thanks to all the health and safety committees, staff reps and staff committees who have been diligently working to bring issues of concern to us and to the administration in your schools. There has never been a time when the work of these amazing volunteers has been more important! Please continue to reach out to each other and to us for support.

### **Rosemary Heights Cohort isolation**

After multiple notices of exposure at Rosemary Heights Elementary, Fraser Health ordered an entire division to self-isolate. This is the first such order in Surrey.

In that situation, the students would receive remote support during the period of self-isolation. If the classroom teacher is well enough to work, they can provide remote instruction. If they are not well, they would be on sick leave (and would have filed a WorkSafe claim if they are positive for Covid), and another teacher would provide the remote instruction. That could be a TTOC, but we have also reminded the employer that there are teachers who were denied accommodations to work remotely who could be doing that work. We have also emphasized the need for the district to provide support to teachers who have to rapidly transition to remote instruction, and to ensure that parents have realistic expectations about how seamless that transition will be.

Virtual Town Hall for the election



Your STA Public Relations and Political Action (PAPR) Committee is hosting an Election Town Hall for provincial election candidates on **Wednesday October 14th at 7:00pm via Zoom**. We hope that this will provide an opportunity for members to learn about the stance of various parties related to education. There will be one or two representatives attending from each of the major parties (NDP, Liberals, and Greens), rather than a huge line up of candidates to consider. Candidates will be given an opportunity to explain their party's stance on various issues related to education, followed by questions from attendees. The event will be moderated by our STA leadership. #### **Fraser Health Contact Tracing**

The STA continues to advocate for teachers to be regularly included in contact tracing when there is an exposure in their classroom. Students, particularly young students, will have difficulty remembering their contacts throughout the day of the exposure. A classroom teacher could greatly assist in strengthening contact tracing. Teachers have access to a great deal of private information of students and can be trusted to be included in this process and respect privacy.

We understand that Jordan Tinney will be recording a video Q&A with Fraser Health. We look forward to more clarification of the contact tracing procedures. We are also requesting a meeting with Fraser Health, along with other BCTF locals in the health region.

Teachers visiting multiple sites (such as TTOCs, Speech and Language Teachers, etc.) should make a daily check of the Fraser Health posting of school exposures to see if they were present at a school for an exposure. Although we have made clear to the District that we expect that all such employees will be informed of exposures, this is an additional safeguard you can put in place for yourself. Here is the link:

#### Safety Plan

TTOCs and EAs need to have access to a safety plan for a student in a classroom they are working with. Please make sure to put a copy of the safety plan in the TTOC and replacement EA folders.

#### **Fogging**

At the present time, portables are being disinfected by hand, not with the fogging machine, as the machine is too heavy to lift safely into the portables. The District is purchasing smaller sprayers to allow custodians to fog the portables in the near future.

If your classroom is not being cleaned properly, inform your administration. Keep track of the occurrences and address it with the Joint Health and Safety Committee at your school. Areas not being cleaned properly is simply not acceptable and holes in the cleaning routines must be fixed.

#### Plexiglass barriers

We understand that some teachers are still waiting for approval of their application for plexiglass, while others have been approved but are waiting for the plexiglass. Ask your principal to contact Nancy Johnston in District Facilities to determine a timeline for when you can expect the plexiglass.

#### **Waiting Area**

A reminder to all schools that there should be a pre-determined area where students who have covid symptoms (cough, nausea, etc.) wait to be picked up that is separated from others. School Health and Safety Committees should ensure that such an area have been designated so they are prepared for a situation where a parent is not able to come immediately.

#### Flu Shots

To avoid large gatherings the district is not having clinics at schools giving shots this year. Instead people

are asked to go to clinics/health units. The District is waiting for a list of who will be providing the shot and will put that in the weekly memo soon. There is a long list of people who get the shot for free. For Surrey Teachers, the Pharmasave, Surrey Centre Location will do the shot for free.

#### **Footwear**

Slip and falls are a large percentage of injuries at schools. A reminder to wear appropriate footwear: flip-flops and very high heels have been determined to not be acceptable. Here is a link with more information:


#### **Room Inspections**

Health and Safety Committee member are beginning classroom inspections. We've always argued that it made the most sense to do the inspection during instruction to get a true picture of the health and safety needs of the classroom. Some joint health and safety committee members were able to get coverage for this duty. However, it may be a better idea in light of this pandemic to ask each teacher to flag concerns with their classroom on the different areas of the inspection form, i.e. electrical, flooring, windows, ceiling, etc. The H&S committee member can come into the room when there are no students (after school?) and gather more details on the issues.

TTOCs: Following B.2.8.b. of our collective agreement, all information which is available about the nature of assignments will be provided to Teachers Teaching On Call when they are called by the dispatch centre. Where a Teacher Teaching On Call has reasonable cause to do so, a callout may be declined.

### Can you use Teams for assessment and reporting?

With more teachers using Teams this year, some are asking questions about whether we can use it for assessment and reporting. The district has offered workshops on using Teams for files and providing evidence of student learning.

Each year we can have three meetings with the District to discuss the reporting tools supported by the District. For elementary, currently FreshGrade and Communicating Student Learning (CSL) templates are supported. In the meantime, please do not assume that you can use Teams for reporting.

## Non-Enrolling Teachers - Are you taking your prep?

Remember that all elementary members are entitled to 110 minutes, and secondary members have one block out of eight (12.5%) over the course of the year as prep. Most non-enrolling teachers don't require a person to cover for them while they take their prep. However, we advise that you schedule and use your prep.

Scheduling your prep gives two specific advantages

- 1. Looking forward to down time, where you can intentionally plan instead of being reactive to school needs is a step for self-care.
- If you are asked to cover Fail to Fill during your prep you can say you are on your prep and that the prep time is owed back to you.

### Call for Resolutions to the BCTF AGM

As you may know, BCTF policy is ultimately created by its members through the AGM, so locals are encouraged to submit resolutions.

If any policy adopted through a resolution were traced back to its source, its origin would probably be in the mind of an individual member, who concluded, as a result of experience or of reflection on problems confronting members, that BCTF policy was lacking or deficient on a particular issue.
