# **Provincial Election coming up!**



This week the STA PAPR (Political Action Public Relations) Committee hosted a virtual town hall on education issues, which was organized to invite representatives from the three main parties to present their ideas on education. Unfortunately, even though we had invited and confirmed their attendance, no representatives from the BC Liberals appeared. # Please meet virtually

The 50+ Covid 19 exposures in Surrey schools are alarming to all of us and we want to emphasize that it is also up to us to change our behaviours at work. For example, if your staff can meet virtually, no matter the size of the meeting, do so. This includes Staff Committee, SBT, department meetings etc. If you normally go to the photocopy room or mail room several times in a day, try to do that once, instead. If you normally would eat with colleagues at lunch hour, eat alone. Yes, it seems somehow negative to isolate ourselves as much as possible during our workday, but it is important that we adults take intentional steps to make sure physical distancing is adhered to. Also, please be sure to sign in if you attend any district facility or school. If you are a TTOC, itinerant teacher, doing your work as an SLP or helping teacher, or dropping off a resource, or meeting a colleague, insist upon signing in! At the STA building we have implemented office building Covid measures, such as eating alone in our offices, entering through specific doors/ stairwells and doing all our meetings remotely, including between table officers. Please think about how your personal habits need to change to prevent the spread of Covid 19.

## Federal benefits relating to Covid

There have been changes to EI, and new federal benefits have been introduced, to address interruptions on work related to Covid. Although the union continues to press the provincial government for a Covid-specific leave, in the meantime there are benefits that can provide income support in various situations:

1) If you must self-isolate, whether you are ill or not

- If you do not have sick days, apply for the Canada Recovery Sickness Benefit, which pays \$500
  per week for two weeks
- It can only be claimed once in a 52-week period. So if you are required to self-isolate twice, you
  cannot claim this benefit for more than the total two weeks. But you would still be eligible for the
  Canada Recovery Benefit.
- If you test positive for Covid-19 and it is connected to an exposure at work, you need to file a WorkSafeBC claim.
- 2) If you applied for an accommodation to work remotely from home, were denied, and are currently on an unpaid leave
  - You should qualify for the Canada Recovery Benefit, which pays \$500 per week for up to 26 weeks
- 3) If your child is ill with Covid or required to self-isolate and you cannot work because you need to care for them
  - Apply for the Canada Recovery Caregiving Benefit, which pays \$500 per week for up to 26 weeks.

For more details, please see the attached document summarizing these benefits. \*\*Please note that if you get any of these benefits, income tax will not be deducted at your full rate, so you can expect to owe further income tax on them at tax time.

#### Notification of TTOC transfer deadline Nov 15

Adding TTOC Experience to Contract

Since September 2014, TTOCs who get a contract and have TTOC days accumulated are able to add the TTOC days to their contract experience in order to go up the salary grid. The TTOC days are divided by 17. Each 17 days equal one month. 170 days are needed for an increase. For a transfer of TTOC experience to be effective December 31, teachers must apply to the payroll department in writing by November 15. And for an increase to be effective September 01, the deadline is June 30.

#### Sick Leave Bank

TTOCs in Surrey who have worked for more than 20 days earn sick day credits for each day worked. They get approximately 1 sick day per every 13 days worked. When TTOCs get continuing contracts their TTOC sick bank should be transferred by the Employer to their contract sick leave bank. If you are TTOC who has just gotten a continuing contract, please check your pay stub to make sure that your TTOC sick bank has been transferred. Also, if know a teacher who has just gotten their first continuing contract, please make sure to share this information with them.
